**I. GENERAL.**

1. These Supplemental Terms and Conditions are in addition to the Raytheon Technologies (RTX) Standard Terms and Conditions of Purchase (revision as indicated elsewhere in this order or subcontract) and the Raytheon Technologies (RTX) U.S. Government Provisions and Clauses for Orders under U.S. Government Contracts (revision as indicated elsewhere in this order or subcontract). These Supplement Terms and Conditions are invoked under the Prime Contract identified above. In the event of a conflict between a provision in this document and Buyer's Standard Terms and Conditions of Purchase, the Standard Terms and Conditions of Purchase shall control to the extent permitted by law except for newer versions of clauses contained herein.
  
2. Supplier shall incorporate the applicable Clauses in each lower-tier subcontract placed in support of this Order.
